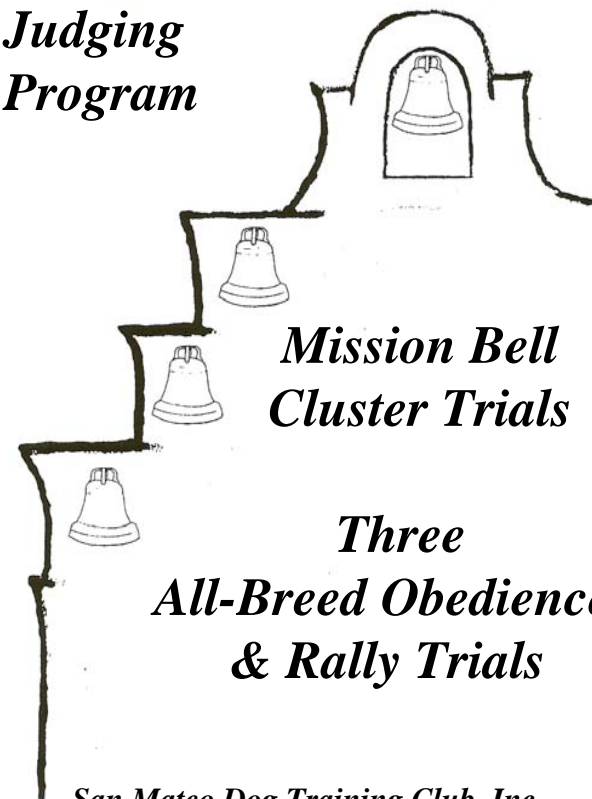
- Exit fairgrounds.

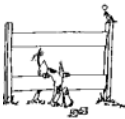
