"Attitude and Attention = Teamwork"

On day one the focus will be on the trainer/handler. We will analyze the way people train—and dissect this. We will examine Attitude — THE HANDLER'S ATTITUDE, and Attention — THE HANDLER'S ATTENTION. And through this approach, bolster the dog's attitude and attention, so that the end result is teamwork.

Catherine will cover seven basic topics — subjects that must be addressed in order to succeed and ultimately attain teamwork.

"An Introduction to Constructing an Exercise – Step by Step"

On day two Catherine will demonstrate how to look at a skill or behavior and break it down into its basic parts, and then show how to teach each part individually. As each little step is learned, one by one, step by step, they are gradually put together to construct the entire skill and exercise. This provides the trainer the ability to isolate any problem that might surface in the future, so it can be solved with little confusion for the dog.

ABOUT CATHERINE ZINSKY

Having trained Dobermans and Cattle Dogs in the past, Catherine currently trains Border Collies. She has been actively exhibiting in AKC, UKC and ASCA trials for the past 40 years, achieving multiple AKC Obedience championships, among others. She has been awarded more than 200 High in Trials, and over 100 High Combined wins. She is also an ASCA Obedience judge. She periodically presents obedience seminars for clubs across the nation.

She contributes a monthly column for Front and Finish dog magazine, has authored the book - *Attitude + Attention = Teamwork! Seven Steps to Success*, and maintains a website - www.gettoready.net with an excellent Competitive Obedience Toolbox.

Catherine's philosophy is founded on the premise that a dog that fully understands the exercise is a confident dog. Her ultimate goal is to help others develop a deeper understanding of the trainer/canine bond and in so doing, have a more rewarding relationship and achieve greater success.

- Dogs must be on leash or crated when not working.
- Bring your own chairs, crates, leashes, toys and treats, water etc.
- Aggressive behavior by dogs shall not be tolerated. To ensure that everyone's seminar experience is a positive one, SCDTC reserves the right to ask that participants' dogs be removed from the facility if they are disruptive in any way.
- Similarly, for everyone's enjoyment, we respectfully ask that you do not bring bitches in season. Should your girl come into season, we will issue a refund if we can fill your spot from the waiting list. We ask that you provide a letter from your vet verifying the season.
- Light snacks will be provided in the morning and afternoon.
- A lunch break will be provided: Safeway is across the road and McDonald's is also nearby.
- Directions to the venue, parking information and instructions for pottying dogs will be sent prior to the seminar.
- In the event of cancellation, auditor fees and working fees will be returned in full; however, monies for traveling and other costs will not. There will be a service fee in the event of returned checks.
