**ATTENTION EXHIBITORS:**

**NO DOGS WILL BE ALLOWED IN THE SHOW AREA EXCEPT THOSE ELIGIBLE TO BE SHOWN.**

(AKC Rule, Chapter 11, Section 11.)

**DOGS MUST BE READY FOR JUDGING.** The Club and its Trial Secretary will not be responsible, and are not obligated to furnish any service for notifying exhibitors or their agents of class judging. Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring.

**DOGS NEED TO BE AT SHOW** only at scheduled time of judging and may leave immediately thereafter, unless required for further judging.

**NO CLASS TRANSFERS ( "Move Ups" ) WILL BE ALLOWED AT THIS TRIAL.**

**NO BITCHES IN SEASON** allowed on the trial grounds.

**FRIDAY: NO SET UP OF CRATES/X-PENS INSIDE GATEWAY UNTIL AFTER 3:00 P.M.** Trial workers may set up AFTER the rings are set up - about 10:00am. People showing in the Run-Throughs may set up after 11:00 am.

**PARKING: \$10.00/day.** Park in Parking Lot A. ADA Parking enter through Gate B, turn into the Administration lot. **RV PARKING:** Contact 408-493-3100 or RVPark@thefair.org
