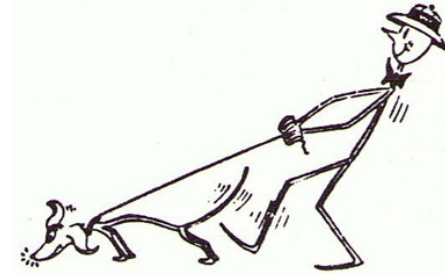

CLOSING DATE FOR ENTRIES: THURSDAY, NOV. 10, 2016 at 3:00 PM
after which time entries will not be accepted, cancelled, or substituted.

ENTRY FEE: \$120.00 (Includes AKC fees). Make checks payable to SCDTC. Mail entries with fee to tracking test secretary. NO fax, online, or "signature required" entries. Consider sending "last minute" entries FedEx.

ELIGIBILITY: All AKC recognized breeds or registered Canine Partners that have earned a TD, TDU, or TDX title. A dog may continue to participate in this test after it has earned the VST title. Priority shall be given to dogs that do not hold the VST title. Entry Method: Draw. Entries limited to 5 dogs.

BITCHES IN SEASON: Bitches in season may participate. Notify Test Secretary as soon as you arrive if your bitch is in season.

DRAWING: A random drawing of entries received by the closing date/time will be held on Thursday, Nov. 10, 2016 at 7:30 PM at Holders Country Inn, 998 S DeAnza Blvd., San Jose, CA 95129. Drawing for the alternate list will immediately follow the drawing for the limited entries.

NOTIFICATION: The results of the draw will be sent as soon as possible after the draw. If email notification is not received by the exhibitor within a reasonable time, please contact the Test Secretary.

REFUND POLICY: Alternates who opt to decline to be placed on the alternate list shall have their full entry fee returned. Entrants and alternates who do not run in this test, but are replaced by an alternate who runs in the test, shall have their full entry fee returned.

TEST HOURS: Test hours are from 6:30 AM – 6:00 PM. All dogs and handlers must be at **EVERGREEN VALLEY COLLEGE** by 9:00 AM, Sunday, November 20, 2016 for the drawing to determine running order. Entrants not present at the time of the drawing will be marked absent and an alternate will be allowed to run in their place.

JUDGING: Judging will begin as soon as the tracks have aged sufficiently.

AWARDS: An award will be presented to any dog earning the VST title.

The **HEALTH AND SAFETY** of the dogs, exhibitors, judges, and spectators is of paramount importance. The test may be cancelled or stopped before completion in case of extreme, hazardous conditions for the well-being of people and dogs. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, and communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.

DIRECTIONS TO EVERGREEN VALLEY COLLEGE, Parking Lot 1A:

From the North or South: Take US-101 to the Yerba Buena exit. Turn LEFT (East) on Yerba Buena Road. Continue East on Yerba Buena for about 2.5 miles. Turn LEFT on San Felipe Road (Wells Fargo, Starbucks) After about ½ mile, turn RIGHT on Paseo de Arboles (first signal after shopping center). Turn left into parking lots. Parking lot 1A is at the back, to the left.

DIRECTIONS TO WEST VALLEY COLLEGE, Parking Lot 6:

From the North: Take Hwy 280 to Hwy 85 South. Exit at Saratoga Ave. Turn right onto Saratoga Ave., then turn left onto Fruitvale Ave. Continue to Parking Lot #6 on your left, opposite Douglass Ave. Expect a \$3.00 parking charge – bring \$1.00 bills.

From the South: Take US-101 North. Exit on Hwy 85 North and continue to the Saratoga Ave. exit. Turn left onto Saratoga Ave., then turn left onto Fruitvale Ave.. Continue to Parking Lot #6 on your left, opposite Douglass Ave. Expect a \$3.00 parking charge – bring \$1.00 bills.

PRACTICING: Practicing on the test site is allowed except for the weekends of Nov. 12 & 13, 19 & 20, 2016. Please adhere to the school's regulations, keep the dogs on leash at ALL times, and pick up.
